NOTICE OF MEETING OF BOARD OF DETERMINATION


Notice Is Hereby Given to you as a person liable for an assessment that the Board of Determination, composed of Fayette Miller, Ken Mitchell, Dan Van Valkenburg, or alternate will meet on Wednesday, June 21st, 2017, at 7:00 o'clock in the evening at the Cambridge Township Hall 9990 W. M-50, Onsted, MI, 49265, Lenawee County, Michigan, to hear all interested persons and evidence and to determine whether the drain known as the Kingsley & Sussex Drain is necessary and conducive to the public health, convenience or welfare, and whether said maintenance and improvement is necessary for the protection of the public health in the following municipalities: Cambridge Township, pursuant to Chapter 4 of Public Act 40 of 1956, as amended.

Your petitioners further show that the said drain needs and asks you to locate, establish and construct a drain or drains, or any portion thereof, which will properly drain the lands and alleviate drainage issues in the district, under the provision of Act No. 40 of the Public Acts of 1956, as amended. The location of the drain, or drains, or any portion thereof, are as given in your Order for Laying Out and Designating the Kingsley & Sussex Drain Drainage District.

Proceedings conducted at this public hearing will be subject to the provision of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the County Drain Commissioner.
