If your client is legally eligible, the Prosecutor's Office may make a plea offer contingent upon successful completion of drug court. *Your client must plead guilty as originally charged. After a plea is entered, you must review the Participant Agreement with your client and bring a signed copy to sentencing and submit it to the drug court.*

*The following criteria are reviewed to determine defendant eligibility*

<p><b>Legal Eligibility Requirements</b> <i>(Background check will be conducted.)</i></p> <ul style="list-style-type: none"> <li>• Must plead guilty to original charge.</li> <li>• Link between offense and use of drugs or alcohol.</li> <li>• No assaultive felony convictions.</li> <li>• No criminal sexual conduct convictions.</li> <li>• No more than 2 prior assaultive misdemeanor convictions.</li> <li>• No more than 2 prior delivery of controlled substance convictions.</li> <li>• No weapon used or possessed in the commission of the crime.</li> </ul>	<p><b>39<sup>th</sup> Lenawee County Judicial Circuit Court Eligibility Requirements</b></p> <ul style="list-style-type: none"> <li>• Age 18 or older.</li> <li>• Legal resident of the United States.</li> <li>• Resident of Lenawee County.</li> <li>• Charge originates in Lenawee County.</li> <li>• No pending assaultive charges of another jurisdiction.</li> </ul>

<p><b>Clinical Eligibility Requirements</b></p> <ul style="list-style-type: none"> <li>• Qualify for substance use treatment at the level Outpatient Treatment, or higher.</li> <li>• No health conditions that require continuous management with medical marijuana, opiate, or other narcotic medications.</li> <li>• No mental illness requiring the long-term prescription of medication with addictive properties.</li> <li>• No severe and persistent mental health diagnosis or significant cognitive impairment.</li> </ul>
