FIRST ORDER OF DETERMINATION

WHEREAS, A petition, dated May 24, 2016 has been made and filed with me, Jennifer L. Escott, the County Drain Commissioner of the County of Lenawee, State of Michigan, praying for the locating, establishing, and constructing of a certain drain described as follows:

Beginning at a point in Loch Erin Lake , said point lying south 90 feet and east 126 feet from the west corner of private park E, Kingsley No. 1 Plat, a part of the N1/2 Section 25 and the SE ¼ Section 24 T-5-S R-2-E, Cambridge Township, Lenawee County Michigan, thence N 51°6' W 161 feet, thence N 37° 13' E 40 feet, thence N 46° 13' E 63 feet, thence N 29° 46' E 50 feet, thence N 6° 56' W130 feet, thence N 61° 11' W 181 feet, thence N 83° 5' W 240 feet to a point of ending according to survey and drawings by ENG Inc., dated June 22, 2018.

The petition was signed by Max Strinby, Lynn Strinby, Delores R. Jones, John H. Jones, Paula M. Bokatzian, Michael Bokatzian, Bonnie Owens, Mark W. Mapes, Terrie Mapes, Charles Schmidt, CJ Goodrich, Brian Goodrich and Shane Loudon, whose lands may be liable for an assessment, and,

WHEREAS, The Board of Determination, consisting of Ken Mitchell, Dan Van Valkenburg, and Fay Miller in a meeting of the Board held on June 21, 2017 according to the statute, by a majority vote of the Board, determined that the proposed drain is necessary and conducive to the public health, convenience or welfare; and,

WHEREAS, As a means of determining the necessity of the proposed drain, I did cause a survey and measurement to be made by a competent engineer or surveyor: ENG Inc., 40663 Grand Oak Drive, Suite A 109, Lansing, MI 48911.

NOW, THEREFORE, The proposed drain having been determined to be necessary and conducive to the public health, convenience or welfare of Cambridge Township, and that the proposed drain should be granted, I do hereby determine from the survey that the drain should be located, established and constructed in accordance with the survey filed in my office and surveys of record on file in the Office of the Lenawee County Drain Commissioner.

I do further order and determine that the name of the drain shall be called the "Kingsley & Sussex Drain" (#711), by which name and/or number it shall thereafter be known and recorded.

It is thereupon further ordered and determined that the commencement, route and terminus of the drain, with the width, length and depth thereof, shall be in accordance with the engineer's survey and of record surveys on file in the Office of the Lenawee County Drain Commissioner.
