






The tentative location of the proposed drain is as follows:

Commencing at an outlet into an existing watercourse at the State Line of Michigan and Ohio in the SW ¼ Section 4, Riga Township, Lenawee County, Michigan, T-9-S, R-5-E, thence proceeding northerly across Section 4, through Silberhorn Highway, across Section 5, through Yankee Road, and across Section 32 to provide adequate drainage relief to the area.

This application is signed by at least 10 freeholders with lands located in Riga Township, with at least five of the freeholders with lands liable for assessment for the proposed Yankee & Silberhorn Drain.
